MAN OF THE YEAR

Andrew J. Castor '84

Shortly after graduating from Purdue with a BS in Accounting in 1985 Brother Castor took a job as an auditor for Associates Commercial Corporation where he spent four years conducting asset-based liquidation audits before finding his true calling.



In 1989 Andrew started with the Federal Bureau of Investigations, where he has served since. He is currently Deputy Associate Deputy Director/Deputy Chief Operating Officer, where he is responsible for oversight of worldwide business operations to include; policy development, compliance, finance and budget, training, human resources, records management, security, strategy development and implementation, business processing re-engineering, information technology, insider threat, and private sector engagement. Provide operational support to entities for national security and criminal investigations.

Prior to his current post in the FBI Director's Office, he has held a variety of Senior Level Executive positions of increasing responsibility in a variety of locations including Cleveland, San Antonio & Washington D.C.

and complex investigative efforts of over 500 special agents and professional staff for high risk security incidents and crisis management response. These efforts also included senior executive situational briefings, personnel asset protection, and compliance to U.S. Laws and Department of Justice regulations.

FBI's Washington Field Office (Special Agent in Charge) – Responsible and lead comprehensive oversight of all criminal investigations and prosecutions in the District of Columbia and Northern Virginia.

FBI's Human Resources Division (Deputy Assistant Director) - Responsible and directed all recruiting / hiring, pay administration, promotion processes and disciplinary outcomes of over 30,000 FBI employees. Developed and implemented a complete overhaul of the special agent career path program; modernized the career progression process to meet the changing mission of the FBI; ensured the FBI had the talent needed to address new and emerging national security threats. Established the FBI's university hiring program to ensure recent college graduates, increased diversity in hiring, and contained recruiting costs.

FBI's Chief Accounting Officer (Section Chief) - Managed and directed oversight of the Bureau's \$8 billion annual budget; enhanced the FBI's financial compliance program to reinforce adherence to applicable laws and regulations and ensured accurate depiction of the FBI financial position. Efforts ensured the FBI received unqualified opinions and was compliant with all applicable laws and regulations.



For his efforts in 1996 he was the Southern District of Texas Federal Law Enforcement Officer of the Year and in 2008 was a Presidential Rank Award Winner.

Brother Castor has remained active in his community – volunteering for Habitat For Humanity and working with Elementary School mentoring programs with underprivileged children throughout his career. While in San Antonio Andy furthered his education, earning a Masters in Business Administration from the University of the Incarnate Word in 1995.

He and Ruth have two children, Christopher and Amanda. “My experience as a Kappa Sigma brother at Purdue University would assist me throughout both my personal and professional life. The experience I gained by participating in valuable community projects and fraternity events provided me with a foundation for successful leadership, to include communication and collaboration skills.

“And my advice to the undergrads would be to take advantage of this opportunity to the fullest by being involved with your fraternity brothers, as well as other campus activities and organizations of interest. In addition to your academics, this interaction achieves your whole college experience. Take the time to learn from those who have different views and opinions than yours.

HALL OF FAME INDUCTEE

James C. Cloyd III, PharmD, '67 '84

As an undergraduate, Brother Cloyd managed to keep busy. He was enrolled in the pharmacy program (he reminds everyone it was a legitimate 5 yr program), served as Grand Master for Chi Chapter and was a member of the Interfraternity Council. He was an unremarkable member of the the chapter's intramural football and track teams. In the Pharmacy School, he was a Research Assistant in the Department of Medicinal Chemistry, an important experience as it convinced that medicinal chemistry would not be his life's work.



Following graduation in 1971, Jim returned to Jeffersonville, Indiana where he joined his father as a pharmacist at Murphy & Cloyd Drugstore. A year later, he joined the pharmacy staff at the federally-funded Park DuValle Neighborhood Health Center, a multi-disciplinary, inter-city clinic in Louisville, Kentucky. That opportunity changed his life as it opened his eyes to opportunities that he has pursued ever since. Realizing he wanted to learn more about drugs and how they worked in people, in 1973 he enrolled in the Doctor of Pharmacy program at the University of Kentucky, from which he graduated in 1976

Opting to pursue an academic career, he accepted a position as an assistant professor in the University of Minnesota College of Pharmacy. That decision, he says, proved to be among the best



decisions, other than marrying Therese Bowman, he has made in his life. The University allowed him to establish an innovative clinical practice in neurology, create and teach several courses on drug therapy, and begin building a research program that focused on the safe and effective use of drugs to treat neurological disorders. Over the years, he advanced through the academic ranks leading to promotion to professor in 1993. Throughout his career he has had the good fortune to be surrounded by wonderful, caring mentors, highly collaborative colleagues, and extraordinary students.

Currently, Jim serves as Professor of Neurology and Experimental and Clinical Pharmacology. He is also the Lawrence C. Weaver Endowed Chair in Orphan Drug Development and the Director of the Center for Orphan Drug Research, which he established in 2005. He has published more than 400 peer-reviewed research papers, abstracts, and book chapters; and has developed 2 drugs that have been approved by the FDA.

Brother Cloyd has been fortunate to receive numerous accolades for his endeavors. Within the University of Minnesota he was selected as a member of the Academy of Distinguished Teachers, received the Clinical and Translational Science Institute Mentor of the Year Award in 2015, and the College of Pharmacy Weaver Medal for distinguished contributions to pharmacy education and research. Nationally he has received the Research Achievement Award from the American Pharmaceutical Association, the Summer J. Yaffe Lifetime Achievement Award

in Pediatric Pharmacology and Therapeutics conferred by the Pediatric Pharmacotherapy Advocacy Group, and the Distinguished Alumnus Award from the Purdue University School of Pharmacy.

He has been actively involved in the community, most recently working with Get Up Stand Up (GUSU), an advocacy group dedicated to helping those with spinal cord injuries realize the greatest recovery possible.

Brother Cloyd has kept up with Chi Chapter as well, regularly attending Homecomings and Hall of Fame events, including introducing brother Steve Springer '67 as the 2015 Man of the Year.

Jim and Therese, his wife of 35 years, have adult two children, Elizabeth and Thomas. He enjoys playing tennis and biking, when the weather permits, of course; and cross-skiing (a sport Minnesotans think is fun). He and Therese are also members of a gourmet group and traveling, exploring both the United States as well as the world.

Brother Cloyd has some sage advice for our current undergrads, "Pledging Chi Chapter resulted in a lifetime of friendships, which are as strong today as when I joined Kappa Sigma. Brotherhood is an oft-used term whose true meaning and impact may not be apparent as undergraduates, but will shape your lives for years to come.

"Don't let graduation cause you to lose the special relationship you have with each other. Instead, work tirelessly to keep the brotherhood you share with each other fresh and vital over your lifetimes."
